Dear Mr. Earle:

During its meeting of 15 January, the Commission reviewed the proposed designs for perimeter security upgrades at the main gate and Gillis Avenue gate of the Naval Observatory and for a perimeter security fence along the waterfront at the Washington Navy Yard. The Commission understands the unfortunate need for such projects and supports the intention to open the waterfront to the public but finds a lack of information to make an informed decision.

More specifically, the Commission is concerned about the need for vehicle security barriers outside the security gates at the Vice President's residence and would appreciate the opportunity to speak with the Secret Service regarding this and future projects. On the Navy Yard project, the Commission would like to see more detailed drawings, including more information regarding proposed landscape improvements. The addition of a landscape architect to the project team is strongly recommended. The proposed fence creates an inhospitable environment because its height, regularity and opacity at an oblique angle over the approximate 2,400 ft length. A site visit would be appropriate for this project and should be scheduled as soon as mutually convenient.

The Commission looks forward to continued review of this project. As always, the staff is available should you or the design team have questions or need guidance.

Dear Mr. Walker:

During its meeting of 15 January, the Commission reviewed the final designs for the perimeter security barriers and guard booths for the General Accounting Office's headquarters building at 441 G Street, NW. The submission was approved with the exception of the design for the guard booths and the aggregate-concrete as shown on the material sample panel.

The members recommend the design for the guard booths be modified so that the roof overhang is eliminated. This will give the booths a rectilinear profile that is in keeping with the clean and simple lines of the main building. In addition, they recommended the use of clear, low-iron content, security glass be used in the windows of the booths instead of the green colored glass presented, so that there is a closer match to the color of the windows in the main building.

The sample of the aggregate concrete proposed for the walkways at the entrances was found to be too coarse in texture and of a color that is not compatible with the existing decorative granite paving at the entrance. To complement the granite, a gray-colored, finer-grained aggregate was recommended.

In order to expedite the process, the details of the guard booth and the selection of aggregate concrete have been delegated to the staff for final review. Please forward revised drawings and new material samples when ready.

Dear Ms. Mavritte:

During its 15 January meeting, the Commission reviewed the concept design for a new chancery building for the People's Republic of China to be located on Lot 12 in the International Center on Van Ness Street, NW. The members unanimously approved the concept submission and were pleased with the bold and dynamic configuration of the building. However, there were several issues raised during the discussion that warrant additional study.

The first was a concern with the building's north elevation facing Van Ness Street. The members felt that this side of the building needs to be very carefully studied so that there is a richness to the detailing, particularly with the large expanses of flat wall. This side of the chancery will be the most visible to the public as they enter or cross through the International Center. The Commission encourages the design team to explore ways in which to add additional layers of detail to the building's walls and grounds. One item on the north elevation the members found to be enticing, but perhaps needing additional study, was the "keyhole" opening in the wall of the garden opposite the entry pavilion. As presented, it was thought that its surround might be a bit too thin and appeared fragile, and the members questioned the character of the view that it framed. This signature feature will require thoughtful detailing to be successful.

A landscape plan that is very carefully composed can greatly help to enliven the streetscape along Van Ness Street. The requisite security fence should also be carefully considered in this plan so that it is visually interesting, complements the building, and enhances the landscape.

The Commission looks forward to the review of the design as it progresses. The staff is available to assist as needed.

Dear Dr. Spelman:

During its meeting of 15 January, the Commission approved the proposed design for Phase I and the proposed concept for Phase II of the new Asia Trail. The need to regrade the trail to provide appropriate access is understood and the blending of native and Asian landscapes creates habitats which are adaptive to the animals without compromising existing ecologies. The use of realistic rock is encouraged wherever possible.

More importantly, there is a grave concern about the sculptural representations of captive animals. One commissioner stated:

“The Zoo is to teach and we are using the animals sacrificially to teach...a legacy of each generation to protect the environment. Children playing on animal (sculptures) is not teaching respect for animals. It's more like an amusement park and you want a much different experience at a zoo than you do in an amusement park...When you have sculptures of animals that are photo opportunities or to play on, it's giving a message to children that animals are to be amusing for us, that we don't have total respect for them. Adding more amusements is the wrong direction to go.”

This opinion was unanimously supported by all the members present at the meeting. Therefore, the Commission recommends the removal or relocation of all animal sculptures.

After the meeting, the commissioner representing landscape architecture expressed some additional concerns. Specifically, more attention should be given to the future structures for the animals. Although working drawings were submitted for staff review, more specific drawings and views of the landscaped spaces should be part of future public presentations.

The presenters are to be praised for providing the large model on which to see the trail and its context. However, it is regrettable that the project did not begin presentations to the Commission earlier in the design process, when substantive changes were a possibility. The Commission looks forward to continued review of the National Zoo for Phase II of the Asia Trail and other upcoming projects, earlier in the design process.


