






The Certificate of Occupancy, Container Permit and Fence Permit have a termination date of December 31, 2022. We are proposing to extend our permits for one additional year to **December 31, 2023** while we continue to navigate a difficult financial market and continued COVID-related construction cost escalations regarding our eventual development of 2715 Pennsylvania Avenue.

In the meantime, we would like to continue operations at Sandlot Georgetown, providing a place of community for the greater neighborhood and a gathering place for all.

Since its grand opening on May 6th, 2021, Sandlot Georgetown has become a place of gathering for the Georgetown community. Hosting weekly cultural events produced by Ian Callender, owner of Sandlot and our site's cultural arts operator, the temporary activation has provided something new to Georgetown and with its seasonal programming, an ever-evolving curation.

Additionally, throughout the course of operation, Sandlot Georgetown has provided various food options to the Georgetown community via food trucks, restaurant pop-ups, and mobile vending food trailers.



Summary of Activity and Mission Statement

Sandlot Georgetown kicked off its second season on April 1, 2022 with brand new partnerships including Beam Suntory (liquor sponsor), City-State Brewing (beer sponsor), and Rawish DC (cold pressed juice sponsor).





In 2022, the Sandlot has brought a number of new food options to Sandlot Georgetown, including Street Jerk USA, Little Miner Tacos, and its newest partnership with Mahal Open Fire BBQ, an American-style BBQ with Filipino influence by James Beard nominee and former executive chef of the National Museum of African American History, Chef Jerome Grant.
